

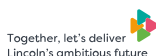
# LINCOLN PUB WATCH

Lincoln Pubwatch Is a pro-active voluntary scheme of Licensees working to create a safe, vibrant and inclusive environment for all its members, staff and customers. Helping combat crime, disorder, public nuisance, and anti-social behaviour with the support of the Police and local authorities within the city centre as described by the Lincoln BIG levy area.

**Membership is open to any venue that has a premises license and/ or involved in the Hospitality sector. The scheme has a two-tier system.**

**Tier 1 members** must be a Licensee, Designated Premises Supervisor or Senior Manager of a venue with an on-trade premises licence within the defined area as set out by the Lincoln BIG Levy zone. Tier one members have full voting rights.

**Tier 2 membership** is available to venues and businesses that are part of the hospitality sector but whose main business is not the sale of Alcohol (ie cafés, restaurants, cinemas, taxi ranks, hotels, fast food outlets, late night shops or agencies) that would benefit the hospitality sector with information sharing Tier 2 members do not have any voting rights.

## **MEMBERSHIP EXPECTATIONS**

---

1. You must attend a minimum of 1 meeting a quarter.
2. You need to attend the meeting after an incident has occurred at your venue.
3. You must have an active login for the Disc App (Provided by Lincoln BIG)
4. You need to keep the information confidential (Meetings and App).
5. You must uphold the bans (Tier 1 members only).
6. You need to be open, if you've let someone in who's barred report the fact. It happens the issue arises when you knowingly let them in.
7. You are active at meetings.
8. You have signed the constitution.

1. You have a CCTV radio.
2. You are part of the Ask for Angela scheme.
3. You are working towards Licensing SAVI (Lincoln BIG Funding).
4. You do not fly post in the city.
5. You maintain a cordial relationship with the authorities.
6. You are courteous to the other venues.
